At such time the Board is so authorized and may adopt rules of procedure, consider a proposed budget for Fiscal Year 2020-2021, adopt an internal controls policy and address any other business that may properly come before it, which are necessary for the proper operation of District.

The meeting is open to the public and will be conducted in accordance with the provisions of Florida law for community development districts. The meeting may be continued to a date, time, and place to be specified on the record at such meeting.
